

# NEVADA PROFICIENCY EVENTS PROGRAM



## CHAPTER BANNER

**Chapter Banner**, a chapter/team event which recognizes a chapter/team that creates a large, colorful banner(s) which illustrates their interpretation of the FCCLA State Conference theme.

**Note:** One medal per entry will be awarded.

A school with multiple chapters may submit a banner for each chapter and for each of the chapter's divisions. (i.e., Nevada Career Tech High School has Culinary, Fashion Design, Interior Design, and Early Childhood chapters and could submit up to eight (8) banners).

### ELIGIBILITY

1. Participation is open to any Nevada state affiliated, FCCLA chapter member.
2. The Chapter Banner must be developed and completed within a one-year span beginning the day following the previous state conference and ending the day of competition.
3. The theme is generally determined by the State Executive Council before the beginning of October. If you would like to know the theme before the conference registration packet is mailed in December, you may check the Nevada FCCLA website or contact the State Adviser.
4. The Chapter Banner project must be planned and prepared by the participants' chapter only.

### PROCEDURES & TIME REQUIREMENTS

1. Each entry will be set up during conference registration in the designated area.
2. Banners will be displayed throughout the entire conference.
3. Banner(s) must be retrieved after the Awards Session.

### GENERAL INFORMATION

1. Each banner must be displayed on its own banner stand. Banners may be vertical or horizontal.
2. The banner must be 5'3" in size. This includes the visible banner from the front view and does not include any part of the banner wrapped around the stand.
3. Here is an example of a 5'3" banner stand made of PVC pipe:
  - 2 pieces of  $\frac{3}{4}$ " PVC cut to 5'3"
  - 2 pieces of  $\frac{3}{4}$ " PVC cut to 3'3"
  - 2 90° corners of  $\frac{3}{4}$ " PVC
  - 4 Ts of  $\frac{3}{4}$ " PVC
  - 4 end caps of  $\frac{3}{4}$ " PVC
  - 4 legs of  $\frac{3}{4}$ " PVC cut to 10" long
  - 2 short pieces cut to 1  $\frac{1}{2}$ " of  $\frac{3}{4}$ " PVCSandpaper  
Vaseline and Glue (optional)

Sand the ends of crossbars and uprights until pieces fit together well and come apart easily. Do not force pieces together if they fit too tightly. You may want to use Vaseline at the joints to make sure they come apart. You may also want to permanently glue the feet pieces together.

4. Participants must be dressed appropriately and professionally.

<i>Use of Theme</i>	Theme should be easy for the viewer to interpret
<i>Originality</i>	Present a unique interpretation of the state conference theme <b>without</b> duplicating conference graphics
<i>Chapter Name/Year Identified</i>	Chapter name AND conference year(s) must be present on the banner (Ex: Nevada High School 2019 or 2018-2019)
<i>Visibility</i>	The overall design should be easily viewed from a distance
<i>Spelling, Punctuation, and Grammar</i>	Banner must look professional with proper spelling, punctuation, and grammar
<i>Elements of Design</i>	Demonstrate knowledge of the elements of design: <ul style="list-style-type: none"> <li>• Color</li> <li>• Line</li> <li>• Shape</li> <li>• Texture</li> <li>• Space</li> </ul>
<i>Principles of Design</i>	Demonstrate knowledge of the principles of design: <ul style="list-style-type: none"> <li>• Balance</li> <li>• Rhythm</li> <li>• Proportion</li> <li>• Emphasis</li> <li>• Harmony</li> </ul>
<i>Overall Appearance</i>	All elements and principals of design should create a professionally appealing banner
