

CHAPTER T-SHIRT

Chapter T-Shirt, a chapter event, recognizes chapters that create a T-shirt that illustrates what the current FCCLA State Conference theme means to their chapter.

ELIGIBILITY

1. Participation is open to any Nevada state affiliated FCCLA chapter.
2. The Chapter T-Shirt must be developed and completed within a one-year span beginning the day following the previous state conference and ending the day of competition.
3. The theme is generally determined by the State Executive Council before the beginning of October. If you would like to know the theme before the conference registration packet is mailed in December, you may check the Nevada FCCLA website or contact the State Adviser
4. The Chapter T-shirt project must be planned and prepared by the participants' chapter only.

PROCEDURES & TIME REQUIREMENTS

1. All T-Shirts must be submitted during conference registration.
2. All T-Shirts must be displayed in an upright, free standing position. Chapters

must provide their own mannequins or stand.

3. T-Shirts may be collected after 5 pm on the final evening of State Leadership Conference, prior to the Awards Banquet.

GENERAL INFORMATION

1. Designs must use words or symbols to interpret the theme of the State Leadership Conference.
2. All designs must be displayed on a **white** Tshirt.
3. The Chapter name and school year must be displayed on t-shirt. If there are more than one entry from a chapter, be sure to label properly (Junior/Senior/Occupational).
4. Applique, embroidery, sewing, glue, stitch witchery, and paint are all elements that are allowed.
5. Participants must be dressed appropriately and professionally.
